- "As provided in District Policy AC (Nondiscrimination/Equal Opportunity), the Poudre School District and Shepardson PTO do not unlawfully discriminate on the basis of race, color, religion, national origin, ancestry, sex, sexual orientation, marital status, veteran status, age, or disability."
- This will be added to Standing Rule 2, General Policies, "c."
- It was moved, seconded, and approved unanimously to add the above wording to the appropriate section of the Standing Rules
- This wording will also be voted on in October at the General Meeting to be added to the Bylaws
- Notice of the October vote will be sent out on Friday to allow for a month's notification
