Principal's Report, Wayne Thornes

- Excited to have finally started
- Things are going as well as can be expected
- Staff is working extremely hard, collaborations going well
- Technology is the biggest challenge
 - All platforms are having issues

- The new playground is in!
 - It looks amazing and the community is really enjoying it
 - Have a few little tweaks, such as adding more wood chips, but is great to have it in
- Request, information as we move forward
 - PSD has advised that we're in a severe budget crisis
 - o PSD-Virtual is overloaded and the District did not budget for that
 - The State won't be able to fully fund schools, either
 - Shepardson has lost a large number of students to either PSD-V, private/charter schools, families choosing to defer enrollment for a year
 - Because of the lost of students, Shepardson has to give back the money the District had already given the school
 - Requesting help with the school's operating budget to allow us to keep our current classified staff
 - Need to cut expected \$27,000 budget to \$15,000
 - The District purchased a subscription to SeeSaw, so the school was able to get \$2200 back, since didn't need to buy our own subscription
 - Looking at other places to save or redirect funds
 - Testing support, garden, coffee fund, Eco Week, field trips
 - Able to redirect approximately \$10,000
 - Discussion about reserves, allocation, fundraising, replenishing
 - Moved, seconded, approved to take remaining funds for school operating budget for the 20-21 school year
 - Budget requests and changes need to go to General Meeting after Board approval
- New Assistant Principal—Laura Sutton
 - Great asset to the school
- · MAPs testing has been interesting and challenging
 - Kids are resilient and adapting

New Business
